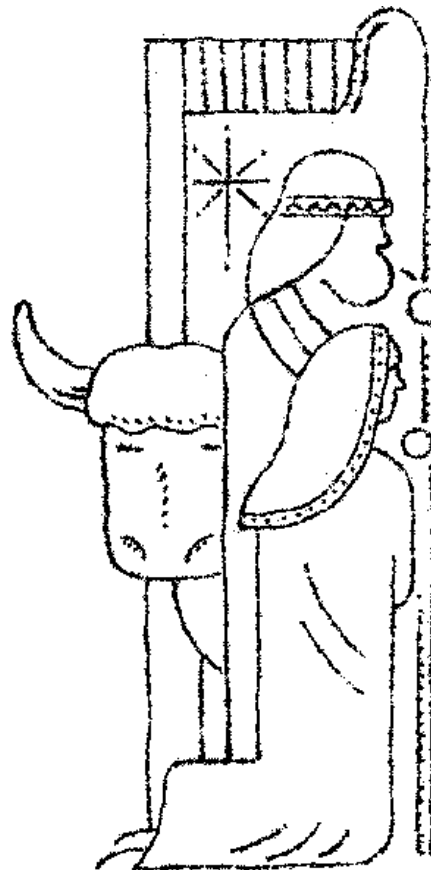

Another artery is totally blocked but the part of the heart that it is feeding is dead from a heart attack. They cannot do the angioplasty procedure because her vessels are too small from diabetes. They have too much plaque buildup. They will start her on medication to stop the spasms and hopefully open up the one artery. She is in Fairfax Hospital.

Mike Holden's niece, Sherry, has been battling cancer for about nine years and is near the end of her fight. She needs encouragement to keep her eyes on the prize, not to lose hope for eternity at a time when there is nothing left but hope.
